SINCE OUR INCEPTION IN 2007, CHILD ADVOCACY HAS BEEN THE HEARTBEAT OF THE WORK OF RESTAVEK FREEDOM FOUNDATION. CURRENTLY, THE ORGANIZATION PARTNERS WITH 32 SCHOOLS THROUGHOUT PORT-AU-PRINCE, TO PROVIDE TUITION, BOOKS, SHOES AND UNIFORMS FOR 750 CHILDREN. TEN CHILD CASE WORKERS MANAGE AN AVERAGE PORTFOLIO OF 70 CHILDREN PROVIDING ENCOURAGEMENT AND ONGOING SUPPORT THROUGH A TRUSTING RELATIONSHIP FOR THE CHILDREN IN THEIR PORTFOLIO THROUGH CONSISTENT VISITS AND MONITORING. EACH CASE WORKER OVERSEES SCHOOL PROGRESS, HEALTH AND PSYCHOSOCIAL DEVELOPMENT OF EACH CHILD. THE ORGANIZATION MAINTAINS AN EXTENSIVE DATABASE, BASED ON CASE FILES, THAT INCLUDES BACKGROUND INFORMATION AND DEMOGRAPHIC DATA ON EACH CHILD, ASSESSMENTS ON THEIR HOUSING, MEDICAL AND WORKING CONDITIONS AND EDUCATIONAL NEEDS. THE ORGANIZATION ALSO RETAINS ANY IMPORTANT DOCUMENTS AS THEY RELATE TO EACH CHILD SUCH AS THEIR BIRTH CERTIFICATES AND REPORT CARDS. RESTAVEK FREEDOM WORKS TO REUNITE CHILDREN WITH THEIR BIOLOGICAL FAMILIES WHEN POSSIBLE, WHILE CONTINUING TO PAY FOR SCHOOLING WHERE IT IS AVAILABLE. THE ORGANIZATION ALSO OPERATES A TRANSITIONAL HOME WHERE GIRLS WHO WERE LIVING IN ABUSIVE SITUATIONS HAVE A CHANCE TO RECOVER FROM THE TRAUMATIC EVENTS IN THEIR LIVES. UP TO 24 GIRLS LIVE IN THIS HOME AND RECEIVE EDUCATIONAL SUPPORT, MEDICAL CARE, PSYCHOSOCIAL THERAPY, LOVE AND SUPPORT.

BUILDING ON THE SUCCESS OF THE ORGANIZATION'S 2012 PASTOR'S CONFERENCE, RESTAVEK FREEDOM HAS HOSTED A LEADERSHIP CONFERENCE IN EACH OF THE 10 DEPARTMENTS OF HAITI. MORE THAN 3,000 PEOPLE HAVE ATTENDED 1 OF 10 CONFERENCES. CONFERENCE SPEAKERS INCLUDED MEMBERS FROM IBESR, THE SOCIAL SERVICE ARM OF THE HAITIAN GOVERNMENT, AS WELL AS BPM, THE POLICE UNIT RESPONSIBLE FOR MINORS. THIS CONFERENCE LAUNCHED THE JUSTICE CURRICULUM, A 12-WEEK STUDY BASED ON JUSTICE TRAINING INCLUDING CHURCHES, SCHOOLS, AND COMMUNITY GROUPS. MORE THAN 70,000 PEOPLE HAVE BEEN ENGAGED THROUGH TRAINING. SONGS FOR FREEDOM, A SINGING COMPETITION HERALDED AS "HAITI IDOL" BY NPR, WAS ALSO AN INITIATIVE THAT STEMMED FROM THE MOBILIZATION EFFORT. TWELVE COMPETITIONS WERE HELD IN ALL TEN DEPARTMENTS OF HAITI. EACH PARTICIPANT WAS REQUIRED TO WRITE ORIGINAL SONGS AND LYRICS RELATED TO THE ISSUE OF RESTAVEK. MORE THAN 80,000 PEOPLE ATTENDED THE FIRST SEASON OF SONGS FOR FREEDOM.

IN SEPTEMBER 2013, THE ORGANIZATION LAUNCHED A RADIO DRAMA CALLED "ZOUKOUTAP" BASED ON THE SABIDO METHOD FOR SOCIAL CHANGE. THE DRAMA CONSISTS OF 78 EPISODES THAT WILL EVOLVE THE AUDIENCES' THINKING AND BEHAVIOR WITH REGARD TO CHILD'S RIGHTS, FAMILY PLANNING AND ULTIMATELY THE RESTAVEK SYSTEM. IT AIRS ON MORE THAN FOURTY RADIO STATIONS IN HAITI AS WELL AS ONLINE AND ON ONE RADIO STATION IN MIAMI, FL. MORE THAN TWO MILLION PEOPLE HAVE BEEN REACHED BY THE RADIO DRAMA.

RESTAVEK FREEDOM FOUNDATION BUILT A COMMUNITY CENTER IN THE SOUTHERN REGION OF HAITI TO OFFER CLASSES TO PARENTS, PROFESSIONALS AND STUDENTS. CLASSES SUCH AS LITERACY, ENGLISH, JOB TRAINING AND REPRODUCTIVE HEALTH EMPOWER PARENTS TO KEEP THEIR CHILDREN AT HOME AND INFLUENCE PROFESSIONALS AND STUDENTS REGARDING RESTAVEK, AWARENESS AND BETTER TREATMENT OF CHILDREN. THE ORGANIZATION HAS BECOME A LEADING VOICE FOR CHILDREN IN RESTAVEK WITH HAITIAN LEADERS, INTERNATIONAL MEDIA OUTLETS, AND AT U.S. BASED CONFERENCES FOCUSED ON GLOBAL ISSUES SUCH AS HUMAN TRAFFICKING. IN OCTOBER 2016, HAITI EXPERIENCED A CATEGORY HURRICANE WHICH INFLICTED SEVERE PHYSICAL DAMAGE TO THE ISLAND. THE ORGANIZATION WAS HEAVILY INVOLVED IN HELPING COMMUNITIES TO RESTORE AND REBUILD INFRASTRUCTURE, HOUSING AND FARMLAND CROPS IN THE AFTERMATH OF THE STORM.
