CURRENTLY, THE ORGANIZATION PARTNERS WITH 32 SCHOOLS IN PORT-AU-PRINCE AND LES CAYES TO PROVIDE TUITION, BOOKS, SHOES AND UNIFORMS FOR MORE THAN 900 CHILDREN. 15 CHILD CASE WORKERS MANAGE AN AVERAGE PORTFOLIO OF 60 CHILDREN PROVIDING ENCOURAGEMENT AND ONGOING SUPPORT THROUGH A TRUSTING RELATIONSHIP FOR THE CHILDREN IN THEIR PORTFOLIO THROUGH CONSISTENT VISITS AND MONITORING. EACH CASE WORKER OVERSEES SCHOOL PROGRESS, HEALTH AND PSYCHOSOCIAL DEVELOPMENT OF EACH CHILD. THE ORGANIZATION MAINTAINS AN EXTENSIVE DATABASE, BASED ON CASE FILES, THAT INCLUDES BACKGROUND INFORMATION AND DEMOGRAPHIC DATA ON EACH CHILD, ASSESSMENTS ON THEIR HOUSING, MEDICAL AND WORKING CONDITIONS AND EDUCATIONAL NEEDS. MORE THAN 3,000 PEOPLE HAVE ATTENDED 1 OF 10 CONFERENCES.
